The Annual GSA TA Soiree is Here!




Calling all Teaching Assistants!

Write a Public Comment - A "How to" Guide

What is a *public comment*?

Executive agencies serve the American public. *Anyone* can <u>comment publicly</u> on a proposed policy for at least **30 days** before it is finalized, and agencies are required to respond to every single comment received. These *public comments* allow your voice to be heard early on, when policies can still be changed!

• Executive agencies are *not* elected bodies; this means public comments are essential to keep the policymaking process democratic.

How can I write a *public comment*?

You can easily search for, learn more about, and write your comment on <u>current</u> proposed policies at the government regulations site.

<u>Effective comments</u> will show sound reasoning, scientific evidence, and/or personal impacts. They will explain what you like and dislike about the proposal.

• *Make it personal*: Use your own words & stories so that your comment stands out.

- *Make it relevant*: Limit your comment to the proposed policy and any changes you want made.
- *Include facts*: Your comment should provide evidence such as personal stories or statistics. Use facts, not personal attacks.
- Read examples: We compiled some examples just for you!

Department of Homeland Security has proposed a <u>**new rule**</u> establishing "Inadmissibility on Public Charge Grounds." Legislative Snapshot!

This is a short summary of federal, state, and local policy or regulation changes from the previous month that are pertinent to grad students at NC State. Midterm Elections Results

- **Federal**: The House of Representatives has flipped to Democrats (40 seat gain) while Republicans have strengthened their Senate majority (2 seat gain).
 - Read about the anticipated impacts of the midterms on <u>higher</u> <u>education</u> and <u>science policy</u>.
- State: One House seat (NC-09) <u>remains uncalled</u>. In the NC state legislature, Republicans maintain control while Democrats have broken the GOP supermajority, <u>taking away</u> the legislature's ability to override gubernatorial vetoes.
- Four out of six constitutional <u>amendments passed</u>, including the amendment <u>requiring photographic ID</u> to vote.
- Department of Education unveils changes to Title IX
 - The Dept. of Ed. has <u>proposed procedural changes</u> for campus sexual assault and sexual harassment disciplinary proceedings, designed to <u>balance</u> <u>the rights</u> of the victim and of the accused.
 - The <u>public comment period</u> for the Title IX proposal is open until January 28, 2019. Individuals wishing to submit a public comment can refer to the LASA Committee's <u>informational one-pager</u> on this subject.
- Homeland Security proposes new "Public Charge" rule
 - On October 10, the Trump Administration issued a <u>notice of proposed</u> <u>rulemaking</u> setting up grounds to deny immigrants admission into the U.S. based on "Public Charge grounds." The <u>public comment period</u> closes on December 10, 2018.
- Update on DACA
 - The Ninth Circuit Federal Court of Appeals <u>upheld an injunction</u> against the dismantling of DACA -- the first time a federal court weighed in on the issue. The case moves <u>one step closer</u> to the Supreme Court.

Update on Potential Government Shutdown

 Congress has until Dec 7 to complete the appropriations process funding the federal government to avert a shutdown. The White House is <u>pressuring GOP</u> <u>lawmakers</u> to include funding for a border wall in the package.
